Conditions for Exclusion and Return**

Your child is being sent home for the reasons indicated below. Please note the "Conditions for Returning" portion of this chart. Your child is welcome to return when those conditions have been met.

Our concern is for the health of your child, as well as the rest of the children and staff. We are also bound by the Health Department regulations that mandate our Exclusion Policy. Following the exclusion helps sickness from spreading to other children and affecting our community.

	Reason for Exclusion	Conditions for Returning
1	Ear thermometer/infrared thermometer temperature reading of 100°F or higher.	Fever free for 24 hours fever free without fever reducing medication.
2	Uncontrolled or persistent cough or makes a "croupy" or "whooping" sound while coughing.	Symptom free without cough suppressant.
3	Breathing- labored, rapid, wheezing.	Symptom free or physician's written approval to return.
4	Uncontrolled diarrhea (two watery stools in a 4 hour period or one not contained by diaper/clothing).	Free of diarrhea for 24 hours.
5	Vomiting, upset stomach with (more than usual infant "spit up").	Free of upset stomach and vomiting for 24 hours and able to take food.
6	Yellowish tint to skin or eyes and/or unusually dark tea-colored urine.	Symptom free or physician's written approval to return.
7	Pain in the eye, redness of the eyelid, irritation, itchiness, discharge, dryness, swollen, puffy or watery eyes: Pink eye (Conjunctivitis).	24 hours after being medicated.
8	Infected area of skin, with crusty, yellow, gummy, dry, dry area/rash: Impetigo, Chicken Pox, Ring Worm, etc.	Skin sores are healed or 24 hours after treatment started or physician's written approval to return.
9	Severe itching of the body or the scalp and/or constantly scratching the head: Lice, Scabies, Poison Ivy, etc.	After treatment, including free of lice, and nits.
10	Fainting or seizures (other than pre-existing conditions) or general signs of listlessness, weakness, drowsiness, flushed face, headache or stiff neck.	Symptom free or physician's written approval to return.
11	Bumps or blisters resembling Hand Foot Mouth Disease or other unidentified rashes.	A physician's note identifying and explaining that the rash is not HFM or a communicable disease OR blisters crusted over, behavior back to normal, as well as following the fever exclusion requirements above.
12	Unusual behavior (cranky, listlessness, crying more than usual, obvious general discomfort, loss of appetite).	Symptom free.
13	Known exposure to someone who tested positive for COVID and experiencing symptoms of COVID including nausea, vomiting, diarrhea, fever, headache.	Current CDC Recommendations.
14	Known exposure to someone who tested positive for COVID and NOT experiencing symptoms but not fully vaccinated.	Current CDC Recommendations.

If your child needs to be removed from the classroom due to a behavioral issue that is causing unsafe conditions or disruptions to the learning environment, you will be notified and asked to pick up your child within 30 minutes of the call/ message. Management will discuss with you what stipulations need to be met prior to your child's return to CLC. CLC reserves the right to temporarily suspend or terminate care if the behavior becomes habitual.
